LUNDIN NORWAY SPUDS DEVELOPMENT WELL ON THE BRYNHILD FIELD

Lundin Petroleum AB ("Lundin Petroleum") through its wholly owned subsidiary Lundin Norway AS is pleased to announce the commencement of the drilling of the first development well on the Brynhild field in PL148, located in the Norwegian North Sea.

The Brynhild field is located adjacent to the Norway-United Kingdom border, some 210 km from the Norwegian mainland. The development of Brynhild involves the drilling of 4 development wells with a subsea tie-back to the Haewene Brim FPSO located at the Shell Pierce development in the United Kingdom sector of the North Sea, 38 km south of the field.

The wells will be drilled using the jack-up rig Maersk Guardian and drilling operations are expected to continue until Q2 2014.

The template with the manifold and the 38 km production pipeline have successfully been installed. Topside modification work on the Haewene Brim FPSO is scheduled to commence in July. First production from the Brynhild field is expected in Q4 2013.

The estimated gross reserves are approximately 23 million barrels of oil equivalents (MMboe) with gross peak production of approximately 12,000 barrels of oil equivalents per day (boepd). The hydrocarbons will be processed at the Haewene Brim FPSO before being offloaded for further transportation.

Lundin Petroleum has a 90 percent working interest in the Brynhild field and is the operator. Talisman Energy Norge is the partner with 10 percent interest.

Lundin Petroleum is a Swedish independent oil and gas exploration and production company with a well balanced portfolio of world-class assets primarily located in Europe and South East Asia. The Company is listed at the NASDAQ OMX, Stockholm (ticker "LUPE") and at the Toronto Stock Exchange (TSX) (Ticker "LUP"). Lundin Petroleum has proven and probable reserves of 202 million barrels of oil equivalent (MMboe).

Reserves and Resources

Unless otherwise stated, Lundin Petroleum's reserve and resource estimates are as at 31 December 2012, and have been prepared and audited in accordance with National Instrument 51-101 Standards of Disclosure for Oil and Gas Activities ("NI 51-101") and the Canadian Oil and Gas Evaluation Handbook ("COGE Handbook"). Unless otherwise stated, all reserves estimates contained herein are the aggregate of "Proved Reserves" and "Probable Reserves", together also known as "2P Reserves". For further information on reserve and resource classifications, see "Reserves, Resources and Production" in the Company's annual report.

Contingent Resources

Contingent Resources are those quantities of petroleum estimated, as of a given date, to be potentially recoverable from known accumulations using established technology or technology under development, but are not currently considered to be commercially recoverable due to one or more contingencies. Contingencies may include factors such as economic, legal, environmental, political and regulatory matters or a lack of markets. There is no certainty that it will be commercially viable for the Company to produce any portion of the Contingent Resources.

Prospective Resources

Prospective Resources are those quantities of petroleum estimated, as of a given date, to be potentially recoverable from undiscovered accumulations by application of future development projects. Prospective Resources have both a chance of discovery and a chance of development. There is no certainty that any portion of the Prospective Resources will be discovered. If discovered, there is no certainty that it will be commercially viable to produce any portion of the Prospective Resources.

BOEs

BOEs may be misleading, particularly if used in isolation. A BOE conversion ratio of 6 Mcf : 1 Bbl is based on an energy equivalency conversion method primarily applicable at the burner tip and does not represent a value equivalency at the wellhead.
