### **JOHAN SVERDRUP UPDATE**

Lundin Petroleum AB, through its wholly owned subsidiary Lundin Norway AS (Lundin Norway), is pleased to announce an update with respect to the progress on the Johan Sverdrup field.

As announced in February 2013 a concept selection was scheduled to be agreed within the partnerships of PL501, PL265 and PL502 (the "partnership") by the end of 2013. The partnership has agreed to extend the process into early 2014 to finalise the concept selection.

Following an extensive appraisal programme over the last two years Statoil Petroleum AS, as the pre-unit operator of Johan Sverdrup, has this morning announced an updated full field gross recoverable contingent resource range of 1,800 - 2,900 million barrels of oil equivalent. The first oil date is estimated to be in late 2019.

In order to facilitate the project's continued progress the partnership is currently working on awarding a FEED contract for the field development thus ensuring that the previously announced timeframe for PDO approval in the first half of 2015 still can be met.

Once the final concept selection decision has been made by the partnership in early 2014 there will be a further announcement outlining the field's development concept including production capacity at plateau, estimated capital costs and likely timing of the different development phases.

# Reserves and Resources

Unless otherwise stated, Lundin Petroleum's reserve and resource estimates are as at 31 December 2012, and have been prepared and audited in accordance with National Instrument 51-101 Standards of Disclosure for Oil and Gas Activities ("NI 51-101") and the Canadian Oil and Gas Evaluation Handbook ("COGE Handbook"). Unless otherwise stated, all reserves estimates contained herein are the aggregate of "Proved Reserves" and "Probable Reserves", together also known as "2P Reserves". For further information on reserve and resource classifications, see "Reserves, Resources and Production" in the Company's annual report.

## Contingent Resources

Contingent Resources are those quantities of petroleum estimated, as of a given date, to be potentially recoverable from known accumulations using established technology or technology under development, but are not currently considered to be commercially recoverable due to one or more contingencies. Contingencies may include factors such as economic, legal, environmental, political and regulatory matters or a lack of markets. There is no certainty that it will be commercially viable for the Company to produce any portion of the Contingent Resources.

## **Prospective Resources**

Prospective Resources are those quantities of petroleum estimated, as of a given date, to be potentially recoverable from undiscovered accumulations by application of future development projects. Prospective Resources have both a chance of discovery and a chance of development. There is no certainty that any portion of the Prospective Resources will be discovered. If discovered, there is no certainty that it will be commercially viable to produce any portion of the Prospective Resources. Unless otherwise stated, all Prospective Resource estimates contained herein are reflecting a P50 Prospective Resource estimate. Risked Prospective Resources reported herein are partially risked. They have been risked for chance of discovery, but have not been risked for chance of development.

## **BOEs**
